- By virtue of an Agreement dated the 3rd December 2013 entered into between the
 Metropolitan Borough Council of Stockport, Manchester City Council and Cheshire
 East Borough Council pursuant to section 8 of the Highways Act 1980 the
 Metropolitan Borough Council of Stockport was appointed as the acquiring authority
 to promote a compulsory purchase order and side roads order to support the
 construction of the proposed A6 to Manchester Airport Relief Road.
- 2. Accordingly the Metropolitan Borough Council of Stockport hereinafter referred to as the "acquiring authority" acting on its behalf and of the other two partnering authorities proceeded on the 5th December 2013 to make The Metropolitan Borough of Stockport (Hazel Grove (A6) to Manchester Airport A555 Classified Road) (Sides Roads) Order 2013 under Sections 8, 14 and 125 of the Highways Act 1980 and on the 6th December 2013 to make The Metropolitan Borough of Stockport (Hazel Grove (A6) to Manchester Airport A555 Classified Road) Compulsory Purchase Order 2013 under Sections 8, 239, 240, 246, 250 and 260 of the Highways Act 1980
- 3. On the 11th December 2013 the acquiring authority submitted the Orders to the Secretary of State for Transport for confirmation together with two copies of the Statement of Reasons.
- 4. Again on the 11th December 2013 the acquiring authority in pursuance of sections 11 and 12 of the Acquisition of Land Act 1981 published notice (see Appendix 1) of the making of the compulsory purchase order and sides roads order in the prescribed statutory forms in local newspapers circulating in the area of each of the partnering authorities. Copies of the notices were displayed on a conspicuous object or objects on or near the land comprised in the compulsory purchase order and land affected by the side roads order and the notices placed on deposit at local centres and libraries

within each of the partnering authority areas along with a copy of the compulsory purchase order and side roads order and a copy of the Statement of Reasons dated the 10th December 2013. Notice of the making and submission of the Orders was served on all persons entitled to be served with such notices along with a copy of the Statement of Reasons.

- The Orders were submitted to the Secretary of State for Transport on the 11th December 2013 for confirmation.
- 6. The expiry date for objections to the Orders to be made to the Secretary of State for Transport was the 31st January 2014. Both statutory and non-statutory objections were made to the Orders.
- 7. On the 10th March 2014 the Department of Transport National Transport Casework Team notified the acquiring authority of the decision by the Secretary of State for Transport for the Orders to be treated concurrently under section 257 of the Highways Act 1980 and for a joint local public inquiry to be held to consider objections to the Orders.
- 8. On the 10th December 2013 the acquiring authority submitted to the Secretary of State for Communities and Local Government a special category land application made pursuant to section 19(1)(a) of the Acquisition of Land act 1981 for a certificate that the Secretary of State for Communities and Local Government is satisfied that public open space forming part of land at Woodford Recreational Ground, Woodford, Stockport which is needed for the relief road will be replaced by land forming part of Moorend Golf Course, situate east of the A5102 Woodford Road, Woodford, Stockport, being land which is not less in area and equally advantageous to persons, if any, entitled to rights of common or other rights and to the public.
- 9. Having been directed by the Secretary of State for Communities and Local Government the acquiring authority on the 30th April 2014 published notice (see Appendix 2) of the section 19 special category land application in local newspapers circulating in the areas of the partnering authorities and placed the application on deposit throughout the partnering authority areas and served notice of the application on all persons who are purported to have an interest in the land contained in the

application inviting representations and objections to be made to the Secretary of State for Communities and Local Government in relation to the application by the 23rd May 2014.

- 10. One objection was received to the S.19 special category land application.
- 11. A statement is appended (see Appendix 3) signed by Martin Touhey, an officer of the acquiring authority certifying that he has displayed the requisite statutory notices when and where required and continued to inspect and maintain the notices for the necessary periods of time.
- 12. On the 16th May 2014 the acquiring authority served on each statutory objector and the Secretary of State for Transport a written Statement of its case for making the Orders, accompanied by a list of all documents including maps and plans, which it intends to refer to, or put in evidence, at the Inquiry and a notice stating the times and place at which such documents may be inspected.
- 13. On the 22nd July 2014 the National Transport Casework Team notified the acquiring authority of the arrangements being made for the Inquiry to be held into the Orders and for the objection to the Section 19 special category land application to be considered at the Inquiry.
- 14. As directed by the National Transport Casework Team, the acquiring authority on the 13th August 2014 posted copies of the notice (see Appendix 4) prepared by the National Transport Casework Team of the Inquiry in places where public notices are usually exhibited and also in a conspicuous place near the land concerned and published notice in the newspapers in which the notices of the making of the Orders were published and
- 15. In accordance with the pre-Inquiry note dated the 30th July 2014, the acquiring authority on the 9th September 2014 served on each objector a copy of the proof of evidence the acquiring authority intends to present to Inquiry to support the Orders and the S.19 special category land application and

16. No later than 48 hours prior to the start of the Inquiry has let each objector who had prepared a proof of evidence or a written statement, have a copy of rebuttal evidence by the acquiring authority and will present any further rebuttal evidence during the first morning of the Inquiry.

- (h) entry to construct, inspect and maintain the works mentioned above.
