#### Addendum

The attached Explanatory Statement was published by the Highways Agency on 8 January 2014 to accompany the publication on that date of draft Revocation Orders under the Highways Act 1980. These Orders were intended to remove previously made Orders that were intended to authorise the Department of Transport to construct the A6(M) Stockport North South/Bypass. The proposals for A6(M) were withdrawn by Ministers in 1998, but the Orders were temporarily left in place to protect the line of the route from development until the local highways authorities could bring forward replacement proposals.

A period for public comment and objections to the draft Orders was open until 20 February 2014. No objections or comments were received in the specified period and the Highways Agency proceeded to have the Revocation Orders made on 8 April 2014. The Orders will come into force on 30 April.

ANY PERSON aggrieved by the made Revocation Order or Orders and desiring to question its or their validity, or any provision contained within it or them, on the grounds that it is not within the powers of the Highways Act 1980, or that any requirement of that Act has not been complied with, may within 6 weeks of 30 April 2014 apply to the High Court for the suspension or quashing of the Order or Orders or any provision they contain.

# WITHDRAWAL OF TR111 AND ROUTE PROTECTION REVOCATION FORMER HIGHWAYS AGENCY PROPOSALS FOR A6(M) STOCKPORT NORTH/SOUTH BYPASS

The Highways Agency hereby gives notice of our intention to withdraw the route protection for the former A6 (M) Stockport North-South Bypass Scheme.

The route protection is to be withdrawn with immediate effect and should not be applicable to the approval of any future planning applications in the designated area. The former route should also no longer be revealed in property searches.

As the name implies, the former A6(M) scheme lies principally in the Borough of Stockport, but approaches and briefly crosses the Council border into Cheshire East near the A523 north of Poynton and this notice relates to that element of the scheme.

For the avoidance of doubt, any other former route protection applied on behalf of the Agency to the A6(M) route by means of made or draft Orders or TR111 notice is also now withdrawn.

Due to the above removal, the Highways Agency is considered to have no remaining planning actions or documentation in place relating to the A6(M) Stockport North/South Bypass scheme. Would you please acknowledge receipt in writing and arrange to return any plans and related documents to me at the address above as soon as possible.

These arrangements have been agreed in liaison with Cheshire East and the SEMMMS Project Team. The withdrawal of the protection follows the making and coming into force of six Highways Act Revocation Orders which revoke formerly made Orders from 1989-90 that protected the line of the proposed route. We understand that your Council has applied sufficient protection for local road schemes that the Council itself may wish to promote in the future.
